Adhesion contract

for rendering services to physical persons who are authors of scientific papers and who are willing to publish their own authorship materials at “Vilin – Professional Editions” LLC (hereinafter referred to as “the Company”).

1. This Contract (hereinafter referred to as the “Contract”) defines the procedure for rendering services to individuals who are authors of scientific papers and who are willing to publish their own authorship materials in the Company’s editions (hereinafter referred to as the “Services”, “Authors” and “Materials”, respectively).

2. The Services hereunder are defined as follows:

2.1 Accepting every Material from every Author, initially to ascertain whether that Material meets the criteria of scientific and practical eligibility for purposes of publication in the Company’s editions. This procedure is carried out by a blind cross-scientific review by reputable health care professionals. As a result of this procedure, the Company makes a decision to publish the given Material or to refuse publishing the given Material;

2.2 After the decision is made to publish a Material in one of the Company’s editions, the latter, as the Contractor, carries out technical editing and technical design of the Author’s Material for publishing purposes.

2.3 By virtue of the Contract, the Author shall initially transfer to the Company’s account 100% prepayment as per Price List for the Services according to subclause 2.1 of the Contract. In case of a negative feedback about the Material for the reasons stated in subclause 2.1 of the Contract, the charge transferred by the Author to the Company’s shall not be returned to the Author.

2.4 After receiving a favorable response for the Material on the grounds set forth in subclause 2.1 of the Contract, the Author should makes in favor of the Company the payment equivalent to 100% of the list price for the Services set forth in subclause 2.2 of the Contract within ten calendar days following the

invoice issued by the Company to the Author. The non-payment of every such invoice entails non-publication of the Material in the Company's editions.

3. The current version of the Contract and the relevant Services Price List are available at: <https://recipe-russia.ru/>.

4. The Contract is provided on the terms and conditions of a public offer pursuant to Article 437 of the Civil Code of the Russian Federation. In particular, the text of the Contract available on the specified official website of the Company is an offer addressed to an indefinite number of persons in order to conclude the Contract on the terms and conditions specified herein.

5. The conclusion of the Contract is effected by adherence of any Author of the corresponding Material to the Contract as a Customer, i.e. by means of accepting (acceptance) by the Author of the Material the terms and conditions of the Contract as a whole, without any conditionalities, exceptions and reservations (Art. 438 of the Civil Code of the Russian Federation).

6. The fact of accepting (acceptance) by each Author of the Material the terms and conditions of the Contract is the complete fulfillment of his/her monetary obligations towards the Company, as the Contractor, in the amount and in the order promulgated by the latter in the Contract.

Provided that the order of payment for the Services is fulfilled, the Contract is considered to be concluded in a simple written form (p. 3 of Art. 438 of the Civil Code of the Russian Federation), not requiring execution of a separate contract in a simple written form on paper with each Author of the Material and having full legal force and effect.

The offer is valid in the version and on the terms that existed at the time of its payment.

7. Payments for the Services to the Contractor shall be made by the Author in Russian rubles personally by transferring money to the current account of the Contractor.

8. The fact of rendering Services by the Company as the Contractor is as follows:

8.1. In the context of subclause. 2.1 of the Contract: the notification of the Author by electronic means of communication or verbally on favorable or negative feedback about the Material intended to be published;

8.2 In terms of subclause 2.2 of the Contract: the fact of the Material's publishing in one of the Company's editions.

9. This offer is not irrevocable; the Contractor has the right to refuse each Author expressing disagreement with the terms of this Contract in publishing the Material.

10. In case of non-fulfillment or improper fulfillment of obligations under the Contract, its Parties assume responsibility according to the current legislation of the Russian Federation.

11. All disputes and disagreements that may arise in connection with the fulfillment of this Contract are subject to negotiation between the Parties.

12. The Parties to the Contract recognize the legal force of texts of documents and messages received by e-mail on an equal footing with documents executed in a simple written form. Documents created (received) by electronic systems specified in the Contract are also recognized as legally valid and effective.

13. When executing the Contract, the Parties are otherwise adhered to the legislation of the Russian Federation in all other matters that do not contradict its terms and conditions.
